# What is the European Test User Certificate?

The European Federation of Psychologists' Associations\* (EFPA) has introduced the European Test User Certificate in order to provide uniformity across Europe in terms of test user qualification standards. The qualification defines European benchmark standards for competence in test use.

The BPS occupational testing qualifications have been accredited by EFPA as together meeting the requirements for the award of the Level 2 Euro Test User Certificate. We are pleased to offer this qualification to a number of our registrants.

## Who is eligible to apply for the European Test User Certificate?

Members of the BPS Register of Qualifications in Test Use (RQTU) who hold all of the following BPS test user qualifications:

- Assistant Test User: Occupational
- Test User: Occupational, Ability
- Test User: Occupational, Personality

## What are the benefits of holding the European Test User Certificate?

- It is a valuable addition to your professional qualifications, indicating a level of competence defined by the European Federation of Psychologists' Associations (EFPA) and further enhancing your existing testing qualifications.
- Multinational test suppliers may recognise the European Test Certificate as a basis for registration of test users across borders within Europe.
- Providers of occupational assessment services and those who seek such services are more likely to acknowledge or require a qualification based on a European standard, such as the European Test User Certificate.
- The European Test User qualification is recorded against your online RQTU profile, which is searchable by employers or clients.

## What are the costs and will I have to renew my European Test User Certificate?

The European Test User Certificate is available for £26. The Certificate remains valid whilst the test user maintains entry on the RQTU
